The Region's Premier T&F Meet

The Columbus *Track & Field* Classic is the premier spring track and field meet for Youth, Open & Masters athletes in the mid-western United States. In recent years, athletes from nine states and three countries have participated.

Fully Automated Timing: Fully Automated Timing (FAT) provided by [Perfect Timing Group](#).

Eligibility: All male & female, Youth, Open & Masters athletes. (USATF and AAU membership not required).

Age Divisions: 8 & Under, Born 2008 or later; 9-10, Born 2006-2007; 11-12, Born 2004-2005; 13-14, Born 2002-2003; 15-18, Born August 1, 1997 through December 31, 2001; Open, Born before August 1, 1995 and less than 30 on meet day; and Masters, Ages 30 and over on meet day (in five-year age groups, e.g., 30-34, 35-39).

On-Line Entries: [Coach-O](#) is the on-line meet entry service for the Columbus Track & Field Classic. On-line entries must be completed by May 18. Entry fees are non-refundable and non-transferable.

Events: 100, 200, 400, 800, 1500, 3000, 1500 walk, 3000 walk, Hurdles (80, 100, 110 youth only); 4x100 Relay, Shot Put, Long Jump and High Jump. USATF rules. **Athletes may compete only in their correct age groups.** Three-event limit for ages 8&Under, 9-10 and 11-12. Four-event limit for all others.

Competition Schedule: Carefully review the Order of Events below to understand the order of competition, especially for the 100m dash. There is no specific start time for track events except the first event begins at 8:30 a.m. and subsequent events will take place after each previous event on a rolling schedule. Age divisions may be combined for field events, walks and events over 400 meters.

Awards: Medals – top 3; Ribbons – 4th – 8th.

PICKERINGTON NORTH HS

Pickerington North High School is the 2016 location for the Columbus Track & Field Classic. This is a one-time change from the Jesse Owens Memorial Stadium at the Ohio State University due to an NCAA lacrosse tournament conflict.

North HS is located at 7800 Refugee Road, Pickerington, Ohio 43147.

DIRECTIONS: Traveling east or west on Interstate 70, take Exit 112 (westbound) or Exit 112A (eastbound) onto State Route 256. Travel southbound on SR 256 about 1.7 miles to Refugee Road. Turn left (east) onto Refugee Road. The school is located about 1.5 miles east of SR 256.

Hotels in the I-70/SR256 area include Comfort Inn, Best Western Executive Suites, Holiday Inn Express & Suites, Fairfield Inn & Suites and Hampton Inn. There are also lots of restaurants in this area.

Waiver and Release of Liability and Indemnity Agreement

For and in consideration of New World Track Club, Inc. allowing _____

to participate in the **Columbus Track & Field Classic** (the "Event"), I, for myself (or for the minor child Athlete named above – Minor Athlete) and on behalf of my (or the Minor and his/her) spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, and Indemnity Agreement (the "Agreement");

I hereby represent that (i) I am at least eighteen (18) years of age or older (or that I am the parent or legal guardian of the Minor Athlete and I am making these representations and signing this Agreement on my behalf, or with and on behalf of the Minor Athlete); (ii) I am (the Minor Athlete is) in good health and in proper physical condition to participate in the Event; and (iii) I am (Minor Athlete is) not under the influence of alcohol or any illicit or prescription drugs that would in any way impair my (Minor Athlete's) ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am (Minor Athlete is) sufficiently fit and healthy enough to participate in the Event, that I am (I as parent or legal guardian am) responsible for my (Minor Athlete) safety and well-being at all times and under all circumstances while at the Event site.

I understand and acknowledge the risks and dangers associated with my (Minor Athlete's) participation in track & field, and race walking and that they are inherently dangerous and will present a test of my (Minor Athlete's) physical and mental limits. I understand that the my (Minor Athlete's) participation involves risks and dangers of bodily injury, loss of or damage to equipment/property; exposure to extreme conditions and circumstances; contact with other participants, spectators, animals or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course or track conditions; equipment failure; participants of varying skill levels; situations beyond the immediate control of the New World Track Club; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks"). I understand that these Risks may be caused in whole or in part by my (Minor Athlete's) own actions or inactions, the actions or inactions of others participating in the Event, or the negligent acts or omissions of the Released Parties defined below, and on behalf of myself (his/her), I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which may be incurred as a result of my (his/her) participation in the Event.

I hereby Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: New World Track Club, Inc.; USA Track & Field, Inc.; Pickerington Local Schools; and Pickerington North High School; their officers, directors, trustees, employees, agents, volunteers officials, coaches and other representatives of any of them (the Released Parties) with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs, defense costs and reasonable attorney's fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation (or participation of the Minor Athlete) in the Event, including claims for liability caused in whole or in part by the negligent acts or omissions of the any of the Released Parties, including with respect to the provision of information regarding rules and scheduling. I further agree that if, despite this Agreement, I, or anyone on my behalf or on behalf of the Athlete, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which may be incurred as the result of such claim.
