I. The meeting was called to order by President Karen Krsak. Thirty two member attended the Zoom meeting.

II. A motion by Jim Engel and seconded by Len Krsak to approve the minutes of the past meeting, and any Zoom meeting minutes that remained unapproved from the 2020 year of Covid Quarantine, as presented by Secretary Terri Tutt. Motion passed.

III. Motion to approve the Treasurer's report, as given by Rich Spielman, was made by Duane Shaul, and seconded by James Perry. Motion passed. (Report to be posted)

**V. Committee Reports- All submitted reports are posted on the Ohio Webpage.**

A. Youth Chair-Lloyd Martin presented the State of USATF Ohio Youth via a PowerPoint presentation. A single location initiative at Cedarville is being pursued for 2020 youth events. He estimates the budget for the 2021 competitive season to run \$12-\$15,000. President Krsak instructed him to fill out a financial request for the funds from the Ohio Treasurer. The Youth Chair Election will be in September of 2021. (Report to be posted.)

B. Race Walk-Barb Hensely reported on and included results from The Ohio Race Walk Championships from September of 2020. Indoor RW has been contested at the Indoor College Level, and will be at the Outdoor College level as well. The Ohio Association 10,000m RW Championships will be held on September 26, 2021 at the Athletes in Action Facility in Xenia. (Report to be posted.)

- C. Masters-Duane Gosa reported that the Outdoor National Masters Championship will be held at Mount Sac this year. TBA. The Master's Throws Championship is on August 20-21 in Seattle WA, and the National Master's Mile is June 12, 2021 in Rochester, NY.
- D. LDR Chair-Paige Biglin - March 31, 2021 will be the date when it will be decided if the first LDR event scheduled for the first Sunday in June of this year will be virtual or in person. President Krsak said there could still be a discount given for the Event Sanction fees.
- E. Men and Women's Track and Field-Phil Wright reported that it has been an active season in the American Track League at the University of Arkansas. The Olympic Trials are scheduled for June 18-27 at the University of Oregon. The Olympics events for Track and Field will start on July 30, 2021. He also mentioned several Ohioans who are currently very successful at National Level. There is a group requesting information on becoming a Post Collegiate Club. They (Mr. Steiner) will be assisted in their request. (Report to be posted)

F. Official's Report-Len Krsak reported that Ohio has 108 official's currently certified. Ohio ranks 3rd in certification. Official's badges are now being processed by the USATF National Office, by Luke Feimrite. They will be mailed to each Certification Chair, and Len said he would mail them out as soon as he receives them. (Report to be posted)

The Balance in the officials account is: \$1,713.72. Recertification of the EDM was completed at a cost of \$367,65.

The next official's clinic will be late summer via Zoom. The next in-person Official's Clinic will be in January 2022.
